Progress of Tekakwitha's Cause

About a year ago, November 26, the first session of the Congregation of Rites was held to consider and examine the virtues of Tekakwitha. This means that statements about these virtues prepared by the Advocate for her canonization were considered, as well as the objections raised by the Promoter of the Faith. As our readers know, the result of this session was entirely favorable.

This year, on November 18, a second session will be held to examine further into the virtues of this Indian Maiden and, if favorable, as there is good reason to expect, a third amd final session will be held early next year.

The object of all this inquiry is to establish not merely that the virtues were practised in an ordinary but in an extraordinary manner; that Kateri was firm in their practice in spite of difficulty even to the length of persecution: in other words, heroic, and heroic to such a degree, that once this fact is established we may style her Venerable.

SOMETHING NEW

To satisfy the wish of many priests and of teachers in our schools, a card, nine by six insches in size, has the prayer for the canonization of Tekakwitha in large type and also the invocation: "Lord Jesus, glorify Thy Servant," etc. A medallion of her with the

title, "The Lily of the Mohawks," is at the top of the card which looks very well printed in blue. Beneath is the legend: "The prayers may be recited after, but not during, any liturgical service, in classrooms, or at sodality and other meetings."

NEW EDITION OF LIFE OF KATERI

Recently there has been such a demand for the brief Life of Tekakwitha, that a new edition was needed and it is now ready under the same title and at the same price as listed on page 8 of this message. Though brief, it is complete enough for a beginning. A longer Life, by the same writer, is now in preparation and very likely it will be ready for the new year.

HOLINESS IN AMERICA

A remarkable collection of documents is now being circulated among the members of the Catholic hierarchy in this country. It is entitled, "Martyrs of the United States of America."

The number of these martyrs is 111. For each the time and place of martyrdom is given, with such details as can be well established, and in nearly every instance, a brief account of the life, virtues and high repute of the martyr's virtue.

Beginning with the proto-martyr, the Franciscan, Juan de Padila, in 1542, the array of men and women in our land who were put to death because of hatred of their faith extends to 1921, from Portland, Maine, to the Vicariate Apostolic of Alaska and in twenty other dioceses, North, South, East and West.

Among the Heroes of the Faith, to use the title of Father Marion Habig's book, were 64 Franciscan priests and 5 brothers; 8 Jesuit priests, 3 brothers and 3 novices; 2 Dominican priests and 1 brother; 5 priests of the Propagation of the Faith; 4 secular priests and 1 Sulpician; 7 laymen; 4 Indian men and 2 women; and notably the venerable Archbishop Seghers.

In the annual conference of our hierarchy in 1939, His Excellency John Mark Gannon, of Erie, Pa., proposed that the prelates assembled should request the Holy See to authorize a common Cause for the canonization of these Martyrs instead of several Causes for each individual or group. To make certain as possible that all these Servants of God really suffered martyrdom, and that during their lives and since they were, and have been since, esteemed for holiness, scholars familiar with the facts concerning them were consulted, with the result that this series of documents has been collected and sent with the petition of our hierarchy to the

Cardinal Prefect of the Congregation Rites, His Eminence Cardinal Salotti. The petition bears the signature of His Eminence Denis Cardinal Dougherty as chairman of the session at which the petition was voted.

DEATHBED REQUEST GRANTED

"Enclosed please find M. O. for \$5.00 in thanksgiving for a request granted my sister (died August 9, 1941). I gave her the prayer to Tekakwitha and she said it faithfully every day.
