### The Good News

On Tuesday, November 18, the Congregation of Rites held its second session for considering the virtues of Tekakwitha. This was about a year after the first session, and maturally one may ask, why are the sessions so far apart? Why take a year examining these virtues?

In the first place, time is needed because there are so many other Causes for the beatification and canonization of Servants of God, and all these Causes are in various stages of progress, some not yet formally introduced; some awaiting the examination of virtues, and others the examination of miracles. Then, one must consider how painstaking and rigorous these examinations are, made by experts who scrutinize not only the facts and proofs submitted, but also the procedure in which they are presented and attested.

This second session is attended not only by the officials and consultors of the Congregation, but also by its Cardinal Members. In the first session, November 26, 1940, the Advocate for the Cause offered in detail proofs of the virtues of Kateri, of her faith, hope and love of God and her neighbor; of her prudence, temperance, justice and fortitude; of her devotions and pious practices—love of Our Lord, particularly in the Blessed

Sacrament and on the Cross; love of the Blessed Virgin, constant prayer, visits to the chapel and habits of penance and mortification.

All this was challenged by the Promoter of the Faith, and his challenges were met by the Advocate. For at least a month before the session the officials and consultors had all this before them in print, so that each might study it thoroughly and be capable of giving an opinion, or of suggesting doubts or questions for further examination or clarification. The opinion in favor of the heroicity of Kateri's virtues was so favorable that the Advocate was authorized to make further study and present new proofs, if any, im order to establish that her virtues are beyond question. The Promoter of the Faith, in turn, was instructed to examine the new proofs and offer such objections as he might deem fit.

Early in October the printed statements of Advocate and Promoter of the Faith were in the hands of all the members of the Congregation of Rites, Cardinals, officials and Consultors and it was on the merit of these that they gave their favorable decision.

At the third session of the Congregation, His Holiness Pius XII will be present to declare the validity of the decisions already given, and in virtue of His declaration, Kateri will be entitled Venerable. This session, we are advised, will be held early next year.

Meantime, steps have been taken to start the examination of the miracles attributed to the intercession of Tekakwitha. There are several, but it is enough to establish two when eye-witnessed. The Postulator of the Cause in Rome petitions the Congregation of Rites to issue Letter Patent to the Bishops of the dioceses in which alleged miracles occurred, in this case, the Bishops of the dioceses of Marquette, Michigan, and of Hamilton, Canada. These are letters of authorization to institute the Apostolic Process on the miracles. This is the last step prior to declaring a Servant of God, Blessed. Pray that it be taken quickly and successfully.

## "For Priests Helping the Cause of Tekakwitha" (Milford, Ia.)

This call for prayers is worth a head-line. Priests generally help to advance the Cause of Tekakwitha. Very many pray for its progress; a large number keep their congregations and especially the societies organized within their parishes informed about this saintly Indian Maiden, and about the process for her canonization; very many also do what they can to help meet the expense of this process here and in Rome; and all this they do, generously and confidently, convinced as they are of the merit of the Cause and sanguine in their hopes of the good results it will bring about.

Nor are priests our only promoters. Sisters of various congregations help devotedly, and men and women of the laity also, not Catholics only, but a good number of others who feel happy to come to know Kateri, as her tribespeople styled her: "The fairest flower that ever bloomed among true men."
