TEKAKWITHA MOVES AGAIN

This number of the Lily comes to you from 30 West 16th Street, New York City, where the Vice-Postulator and the staff of Techakwitha League have been happily established since late last month. We moved along with Gilmary Society, publisher of the Catholic Encyclopedia, Dictionary and Supplements, of which the late Father John Wynne, S.J., was one of the founders.

Kateri's new home is part of the Xavier Community. Here are Xavier, Manhattan's Jesuit Military High School, founded in 1847; Xavier Labor School, an adult school of Industrial Relations; the Catholic Information Center, the St. Patrick's Clerical Club for delayed vocations to the priesthood, the

Xavier Alumni Sodality, an association of prominent Catholic college graduates; the Jesuit Parish of St. Francis Xavier, the Xavier Nocturnal Adoration Society, and other organizations active in the life of the Archdiocese. We are just two short blocks from Union Square — half a block from the Communist Jefferson School, and right across the way from Planned Parenthood headquarters. So Kateri, as of old, is in a familiar setting, safely in the hands of her old friends, the Jesuit missionaries, and in the old familiar pagan surroundings.

MIRACLES

We received a letter last week from Father MscQuade, S.J., of this community, who is on bursiness at Rome, giving an eyewitness account of the miracle which occurs every year there, when the congealed blood of St. Januarius becomes liquid.

Now, as you know, the only thing that is keeping our Kateri from her beatification is that two clear physical miracles due to her intercession must be presented to the Congregation of Rites in proof of her sanctity. Our pages keep telling you of the numberless favors people all over the country are receiving through her. But not the two events we most need. Please: let us know of any remarkable cures which you believe have been the result of the intercession of Tekakwitha, and, if you want our help to obtain a miraculous favor, let us know the circumstances and we can organize a private Novena, and lend you a relic for the period of invocation.

Action in Rome

With the help of this summary and of the original evidence he draws up his arguments in writing. To these the advocate in turn replies. The three documents, the 'positio,' the objections and the reply, are now printed and circulated among the members of the Congregation thirty days before their meeting.

At the meeting, the Cardinal Ponente puts the question whether the Cause should be introduced, and with the help of the printed documents the members give their decision. If it is favorable, they recommend that the Pope, if he wills, should sign the commission for the introduction of the Cause. If he does so, the Cause is withdrawn from the jurisdiction of the local Bishop and placed henceforth under the authority of the Congregation of Rites.

The Congregation then examines the process showing that no public *cultus* has been given to the servant of God, and if it is satisfied on this point, the Cause proceeds, though no formal decree is issued. Still no public honor may be given, and the servant of God may not yet be called Venerable.

Apostolic Processes

From now on all the processes are called 'Apostolic.' This means that even though they take place in the diocesan court, they are authorized by the Holy See, and governed at every step by its instructions.

What is known as "Remissorial Letters" are sent from Rome to five ecclesiastics, naming them judges. If the local Bishop is among the number, he acts as president. In any case he is required to lend the judges his support and authority.

Instructions are also sent by the Promoter General of the Faith to two ecclesiastics who are to act as his delegates. At each session of the court three judges and one sub-promoter are sufficient.

The first session concerns reputation for sanctity, and the report of martyrdom or miracles. But if there is no doubt that this general popular opinion remains, Rome will easily allow the process to be omitted, as having been sufficiently covered in the information process.

Heroic Virtues

A second, more important set of processes has to show that the servant of God exercised each of the theological virtues — Faith, Hope, and Charity, and the four great moral virtues — prudence, justice, fortitude and temperance. And this must be proven to be heroic — not merely ordinary. In the case of Martyrs, at this stage the fact and cause of martyrdom must be established. Normally, too, Rome gives instructions at this time for the body to be exhumed and minutely examined.

Two Miracles

Then at least two miracles must be definitely proved in detail. Sometimes these are not required in the cast of Martyrs. Do not misunderstand this exception, however: it refers only to the process looking towards beatification, and is not allowed in the later stage of canonization.

The procedure, so far as judges, witnesses, oaths, etc., is concerned, is much the same as in the earlier processes. But in the matter of miracles presented for discussion, the court calls in a doctor, a specialist if possible, in the particular disease which is alleged to have been miraculously cured. He assists in examination of witnesses and suggests the questions which will help to make the truth clear.
