### **AURIESVILLE**

HOLY HILL

We know of an American who once visited a famous European health resort in frantic search for some relief from an ailment of the bones. On arriving there, the doctor in charge told him that the best possible source of relief from his particular ailment was a little spa just seven miles from the gentleman's own home in America.

Increased travel facilities have made us more pilgrimage-minded. It is possible to visit Rome and Lourdes and Assisi and Fatima within the time allotted for our vacations. Yet how many Americans are aware of the important Shrine in their own "back yard," so to speak!

The Mohawk River today winds its lazy way between the low hills and friendly countryside in upstate New York. Just before it reaches Amsterdam, it swerves sharply to the left, away from one hill on its right bank. That hill is Auriesville. At first glance it is as quiet and unassuming as all the rest, but, unlike the others, it is the holiest hill in the United States. Pope Pius XII described Auriesville as "Nature's own reliquary"—the verdant hill that slopes up from the quiet, easy flowing river of the Mohawks.

## THE REASON WHY

It is the holiest hill in the United States because a series of events took place there three hundred years ago which make one of the most extraordinary stories in the annals of man's heroic struggle to better this world.

Elsewhere in the United States there are permanent visible signs of the prodigious efforts of the early missioners of our land-Dominicans, Franciscans, Jesuits, Recollets, Diocesan clergy. At Auriesville only the hill remains in view. But in its rich brown earth lie the blood and bones of its martyrs. Beneath its soft green grass lie the remains of the face and features, the mangled hands and bruised bodies of Jogues, Goupil, La-Lande, first canonized Saints of New York State. Goupil's body is certainly in the ravine there; and most likely the skulls of Fathers Jogues and John LaLande elsewhere on the hill. Auriesville is holy, too, for the added reason that ten years after the 1646 martyrdoms, Tekakwitha, first fruit of the Martyrs' blood, was born. And only a few miles west, on the north side of the Mohawk, she was reborn through Baptism.

There are Shrines today at Auriesville and Fonda, worthy of pilgrimage. The Indians have all but vanished from New York. But altars mark the spot of the martyrdoms. The whole Auriesville earth is an altar. The Church has gloriously flourished in the country watered by their blood. And the fairest flower of Indian womanhood, Venerable Kateri Tekakwitha, will one day, please God, be raised to the glory of canonization, completing the happy ending to the story of "three men and a maid" who have sanctified this holy hill.

#### How To GET THERE

Take the New York Central either to Amsterdam from the East, or Fonda from the West; thence by taxi to Shrine.

Via plane, to Albany-Schenectady Airport, airport taxi to Schenectady, thence bus to Amsterdam.

By car, from Buffalo: Route US 20, from 20 to 5-S by 80, 10 or 148.

By car, from New York City: Henry Hudson Parkway to Sawmill River Road to Taconic State Parkway to 199 to US 9 at Redhook to Albany to US 20 to 148 at Sloansville, right on 148 to Glen, right on 161 to Shrine Road, 288.

By car, from Boston: US 20 (Common-wealth Avenue) through Albany to route 148, etc., as from New York.

#### Notes on the Cause

We were asked by a newspaperman recently whether we had arranged to have Tekakwitha's canonization in 1956, the three hundredth anniversary of her birth at Auriesville. Man proposes-God disposes! After purchasing another home to live in she was informed that they had changed their minds, and that she would not be able to receive any compensation for two years to come.
