## TEKAKWITHA IN THE NEWS

Many letters have come to us from all parts of the country asking verification of, or comment on the recent news items about the present state of Tekakwitha's Cause. We were as surprised as everybody else to read the NC story radioed to this country by their Rome bureau:

Vatican City, June 14 (Radio, NC)— Officials at the Sacred Congregation of Rites denied that a new miracle has been submitted to that body to further the beatification of Kateri Tekakwitha, Indian maid who died in 1680. Officials at the Congregation — which is the Vatican body that studies and pronounces on cases of sanctity — stated that a medical commission had examined two alleged miracles wrought through the intercession of Kateri Tekakwitha. One of these miracles was accepted by the commission and the other rejected, it was pointed out. Except in cases of martyrdom there must be absolute proof of at least two miracles through the intercession of a candidate before the Vatican proceeds with beatification.

#### **OUR OWN COMMENT**

No formal presentation of evidence in the case of any purported miracle has been made by this office in recent years. Upon being asked to discuss the news item by the NC, we sent them the following data about the status of the Cause at this time.

### PRESENT POSITION OF KATERI

Venerable Kateri Tekakwitha, daughter of a captive Christian Algonquin mother and a pagan Mohawk father, was born 1656 at Ossernenon, now Auriesville, New York, baptized Easter 1676 at Caughnawaga, now Fonda, New York, and died April 17, 1680 in Canada. Her relics are preserved at Caughnawaga, Province of Quebec.

Her Cause of Beatification and Canonization was introduced at Rome May 19, 1939. The Decree declaring her virtues heroic was issued January 3, 1943. This Decree entitles her to be called Venerable.

Present status of the Cause: a search is being made for the two miracles attributable, under God, to her intercession, which are required before further steps towards Beatification are made.

All matters relating to Tekakwitha's Cause at this stage are presented to the consideration of the Sacred Congregation of Rites at Rome by the Postulator for her Cause, the Rev. Charles Miccinelli, S.J. Two Vice-Postulators have been delegated to further her Cause in North America; for the United States, the Rev. Thomas J. Coffey, S.J., with office at 30 West 16th Street, New York City, N. Y.; and for Canada, the Rev. Henri Bechard, S.J., with office at Caughnawaga, Province of Quebec.

#### THE WORK BEING DONE

All the activities of the Vice-Postulator's office at this time are directed to the encouragement of devotion to Tekakwitha, the dissemination of information, and particularly to fact-finding, sifting of evidence, and the preparation for ecclesiastical tribunals all under the direction of the Congregation of Rites, to take the evidence of eye-witnesses and others regarding purported cures.

It devolves upon the Postulator at Rome to present such evidence to the Congregation, and upon the Congregation to appraise and interpret the evidence and to draw appropriate conclusions.

The files of the New York office contain numerous reports of alleged instantaneous physical cures which their narrators relate to the intercession of Tekakwitha. Several of these, at first glance, seem to have the miraculous stature required for presentation to the Congregation. Two such events are being thoroughly examined on the local level in the United States, and there is a constant sifting and gathering of pertinent data,—but none, to the knowledge of the American Vice-Postulator, has been formally presented to the Congregation in recent years.

#### THE LONG WAIT

There is a constant flow of letters into the office of Tekakwitha League in New York from devotees of Kateri attesting to their faith that miracles of grace and healing have come through her. Clear, unshakeable proof of the latter is required by Rome to show that a servant of God proposed for beatification has been the instrument used by divine Providence to bring about the "something wonderful" which is considered a miracle. Inquiry is long, painstaking and searching.

Diagnosis, prognosis, medical chart, etc. all must be declared in detail. State of the person cured before, during and after the supposed event, and the relationship of the cure to positive intercession of Tekakwitha alone, are patiently probed. Medical experts are called in, but they are not asked to express their opinion as to whether the cure was miraculous or not. That is a matter for the Congregation to decide.

It takes almost a miracle to prove a miracle.
