OTHER CAUSES

We had a cordial visit the other day with Father Francis J. Litz, C.SS.R., recently appointed Vice-Postulator of the Cause of the Wenerable Bishop John N. Neumann, C.SS.R. Father Litz is anxious to hear from Americans who are devoted to the memory of the saintly Redemptorist. His Cause, canonically, parallels Tekakwitha's, since both have been declared to have possessed heroic virtues, and have been declared Venerable. Bishop Neumann, born in Bohemia, as a diocesan priest cared for the souls of German immigrants mear Niagara Falls, 1836-40. In the latter

year he became a Redemptorist, built parishes and rose to high office in his Congregation. Made Bishop of Philadelphia in 1852, his life was indefatigable and holy. Fifty churches in five years, a preparatory seminary, the introduction of sisterhoods for girls and the Christian Brothers for boys, are proof of his zeal. He died in Philadelphia, and his tomb may be visited at St. Peter's Church there. Further information may be obtained by writing to Father Litz there—1019 N. PIUS IX AND MOTHER SETON

Another important appointment was made lately in the naming as Vice-Postulator for the Cause of Pope Pius IX, "Pope of the Immaculate Conception," of Father Salvator M. Burgio, C.M. Father Burgio has been, since 1939, Vice-Postulator of the Cause of Mother Seton. In a recent number of the Mother Seton Guild Bulletin, tribute is paid two our own late Father John Wynne, S.J. The author says: "Realizing that Causes of Canonization in the United States are still in the pioneer stage, Father Burgio saught the

tutorship of Father Wynne, who was then Vice-Postulator of Tekakwitha's Cause, and who had helped immeasurably to pave the way for the Canonization, in 1930, of the North American Martyrs. Father Wynne is considered the *Father* of Vice-Postulators in the United States. His guidance has made possible the effective promotion of Mother Seton's Cause. MARTYRS OF THE UNITED STATES

It is perhaps not widely known that joint beatification and canonization is being sought for one hundred and sixteen (perhaps five more) Martyrs who died on the American scene. The list was compiled under the direction of Bishop John Mark Gannon of Erie, Pa., and sent to the Congregation of Rites at Rome by Cardinal Dougherty, late Archbishop of Philadelphia. The roster begins with the proto-martyr of the United States, Father Juan de Padilla, Franciscan, who died,

probably in Central Kansas in 1542, a full century before St. Rene Goupil, first of the canonized North American Martyrs to die in New York State. The list ends with a diocesan priest, Father James Edwin Coyle, of Mobile, Alabama, who died August 10, 1921. This formidable record of martyrdom for the faith in the United States includes Franciscans, Dominicans, Diocesan priests, Jesuits, Sulpicians, an Archbishop, Indian laymen and French soldiers.

OUR OWN CAUSE

New biographies of Tekakwitha have been published or are in the making. Treasure of the Mohawks, by Teri Martini, is for children, published by St. Anthony Guild Press. I am Indian, a fifty-page brochure by Father Gualbert Brunsman, O.S.B., may be obtained at St. Paul's Indian Mission, Marty, South Dakota. Farrar and Straus of New York will publish a biography in English, and at the same time in French, by Bernadette Savard and Evelyn Brown. From Paris we hear Agnes Richomme's illustrated album on Kateri will appear this Spring in the series Belles histoires et belles vies (Editions Fleurus, Paris Ve) with a preface by His

Eminence Cardinal Léger of Montreal. A new film script for television and movies, as well as a three-act play on Tekakwitha are being prepared by Many Productions of Dumont, N. J. And while all this interesting literary activity is proceeding, would any of Kateri's artist clients like to try their hand at a definitive painting?

There is nothing we can add at this time to what you already know from these pages about the progress of Kateri's Cause. We are still awaiting, prayerfully and hopefully, the two definitely accepted miracles needed to assure the Lily that next long step to the altar.
